**FINAL JUDGMENT ON DEFENDANT'S
MOTION FOR ATTORNEYS' FEES AND COSTS**

This cause came before the Court for evidentiary hearing on Defendant, STATE FARM MUTUAL AUTOMOBILE INSURANCE COMPANY'S Motion for Attorneys' Fees and Costs on January 9, 2012. ORDERED AND ADJUDGED as follows:

1. The Court has considered the mandates, factors, and requirements in Florida Patient's Compensation Fund v. Rowe, 472 So.2d 1145 (Fla. 1985), Standard Guaranty Insurance Co. v. Quanstrom, 555 So.2d 828 (Fla. 1990), and State Farm Fire & Casualty Co. v. Palma, 555 So.2d 836 (Fla. 1990) and their progeny, and Rule 4-1.5 of the Rules Regulating the Florida Bar.



5. Defendant, STATE FARM MUTUAL AUTOMOBILE INSURANCE COMPANY, shall recover from GENERAL HEALTH MEDICAL, INC. the total sum of (attorneys fees, expert fees and costs) \$40,426.20 that shall bear interest at the rate of 6 % a year, for which let execution issue forthwith.

6. It is further ordered and adjudged that the judgment debtor, GENERAL HEALTH MEDICAL INC., shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the judgment creditor's attorney, Jeffrey B. Tutan Esq., within 45 days from the date of this final judgment, unless the final judgment is satisfied or post-judgment discovery is stayed.

7. Jurisdiction of this case is retained to enter further orders that are proper to compel the judgment debtor to complete form 1.977, including all required attachments, and serve it on the judgment creditor's attorney, Jeffrey B. Tutan, Esquire, 1255 S. Military Trail Suite 100 Deerfield Beach, Florida 33442.
